- All capitalized terms used but not otherwise defined herein shall have the meaning given to them in the First Report of the Monitor, dated November 28, 2024 (the "First Report"), the second report of the Monitor, dated February 7, 2025 (the "Second Report"), and the Third Report of the Monitor, dated March 11, 2025 (the "Third Report").
- 2. The Applicant, KSV Restructuring Inc. in its capacity as the "**Monitor**" in the within proceedings, seeks the following relief:
 - (a) A restricted court access order substantial in the form attached hereto as Schedule "A"
 (the "Sealing Order") sealing Confidential Appendix "1" to the Third Report;
 - (b) Abridging the time for serving and deeming service of this application and supporting materials good and sufficient; and
 - (c) Granting such further and other relief as may be sought by the Monitor and this Honourable Court may deem appropriate.

Grounds for making this application:

Background of Proceedings

- On May 29, 2024, 420 Parent, 420 Op Co and a related entity Green Rock Cannabis (EC
 1) Limited (the "NOI Entities") each filed a Notice of Intention to Make a Proposal ("NOI"), pursuant to Section 50.4(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985,
 c. B-3, as amended (the "BIA") (the "NOI Proceedings"). KSV Restructuring Inc. ("KSV") consented to act as proposal trustee (the "Proposal Trustee") in the NOI Proceeding.
- 4. On September 19, 2024, the NOI Entities and 420 Dispensaries Ltd. (together with the NOI Entities, the "CCAA Applicants") sought and obtained an initial order (the "Initial Order") from the Court of Kings' Bench of Alberta (the "Court") granting, among other things, a continuation of the NOI Proceedings under the Companies' Creditors

Arrangement Act, R.S.C. 1985, c C-36, as amended (the "CCAA") (the "CCAA **Proceedings**"). As a result of the Initial Order, the Proposal Trustee became the Monitor.

Sealing Order

- 5. The Monitor seeks a Sealing Order over Confidential Appendix "1" to the Third Report on the basis that it contains a summary of information related to bids provided pursuant to the Court-approved SISP conducted by the Monitor in conjunction with CCAA Applicants.
- 6. Confidential Appendix "1" contains confidential and commercially sensitive information about the SISP and the bids received as part of that process. If such information is made publicly available and the Proposed Plan is not implemented, the value of bids and resulting transactions in a future sales process could be detrimentally impacted. In the event that the Proposed Plan is not implemented, disclosure of the information contained in the bid summary could unduly hinder any future efforts taken by the CCAA Applicants or the Monitor to remarket assets in these proceedings or in any other insolvency process.
- 7. Sealing Confidential Appendix "1" is the least restrictive method available to prevent the dissemination of confidential and commercially sensitive information. The salutary effects of the Sealing Order, which are to protect the general commercial interest of maintaining confidentiality and commercially sensitive information, far outweigh the deleterious effects of restricting accessibility of court proceedings. Further, the effects of the Sealing order will be time limited to (i) the termination of these CCAA Proceedings; or (ii) further order of this Court
- 8. Such further and other grounds as counsel may advise and this Honourable Court may permit.
