The Appeal will be opposed.

Description of the Appeal:

This Action was commenced by Four20 in February 2020 against the Defendants, Tilray Inc and High Park Shops Inc ("High Park") under an Arrangement Agreement. High Park counterclaimed

for a loan advanced to Four20 within that process. High Park sought summary judgment on its counterclaim, which was granted by Applications Judge Farrington on February 7, 2024 (the "CC Decision"). The CC Decision is under appeal by 420.
