**NOTICE TO RESIDENTS OF RAVINES SENIORS' SUITES**

**RE: ASHCROFT URBAN DEVELOPMENTS INC. AND CERTAIN AFFILIATED COMPANIES  
(COLLECTIVELY "ASHCROFT")**

As you may have heard, certain of the businesses that Ashcroft operates have recently been experiencing challenges, including certain of the retirement residences which operate under the "Alavida Lifestyles" banner. As a result, Ashcroft commenced a court-supervised restructuring proceeding under the *Companies' Creditors Arrangement Act* in early December 2024 to restructure and stabilize its businesses. That proceeding, and the responses to it from Ashcroft's lenders, led the court to issue an order on January 3, 2025 (the "**Interim Receivership Order**") which, among other things, appointed KSV Restructuring Inc. as Interim Receiver of Ashcroft's businesses.

**So what does this mean for you?** First and foremost, the priority is maintaining the continuity of care, services and programs presently being provided at Ravines Seniors' Suites. Alavida's existing team members will continue to provide you with the services and assistance to which you've become accustomed. There is no change in your monthly billing or payment arrangements. You are expected to continue to pay your rent and services in accordance with your present rental agreement.

The Interim Receiver will be working closely with the leadership teams and staff members at each Alavida community. The Interim Receiver also intends to retain a property manager that specializes in managing retirement care communities to augment the existing management team at each community.
