Subject: Danier Leather Inc.

On February 4, 2016, Danier Leather Inc. commenced insolvency proceedings by filing a Notice of Intention to Make a Proposal ("NOI") pursuant to the *Bankruptcy and Insolvency Act*. KSV Kofman Inc. was appointed as the trustee (the "Proposal Trustee") in the NOI proceedings.

Pursuant to an Order made on February 8, 2016 by the Ontario Superior Court of Justice, the E-Service Protocol of the Commercial List was approved and adopted in these proceedings. Pursuant to the E-Service Protocol, the Proposal Trustee is sending this email to identify itself as the "E-Service List Keeper" and to advise that: (i) you have been placed on the E-Service List; (ii) court documents will be validly served upon proposed stakeholders by email; and (iii) any stakeholder on the E-Service List may serve court documents on any other stakeholder on the E-Service List in accordance with the E-Service Protocol.
