**ORDER GRANTING STIPULATED

1 Upon consideration of the *Stipulated Motion To Extend Certain Discovery And*
2 *Pretrial Deadlines* (the “Stipulated Motion”)¹ filed by Patriot Gold Corp. (“Patriot”) and
3 Defendants Golden Vertex Corp., Elevation Gold Mining Corporation, Golden Vertex
4 (Idaho) Corp., Eclipse Gold Mining Corporation, Alcmene Mining Inc., and Hercules Gold
5 USA LLC (collectively, the “Defendants”), and for good cause appearing therefore,

6 **IT IS HEREBY ORDERED AS FOLLOWS:**

- 7 1. The Stipulated Motion is hereby **GRANTED**.
- 8 2. The discovery deadlines set forth in the Joint Discovery Plan are hereby
9 amended as follows:
- 10 a. **June 20, 2025** – Deadline to Exchange Final Disclosure Statements under
11 Rule 7026
- 12 b. **May 16, 2025** – Deadline to Disclose Identity of Expert Witness(es) and
13 Disclose Written Reports Pursuant to Rule 7026(a)(2)(B)
- 14 c. **June 6, 2025** – Deadline for Non-Expert Depositions
- 15 d. **June 6, 2025** – Deadline to Disclose Rebuttal Expert Reports
- 16 e. **June 20, 2025** – Deadline for Expert Depositions
- 17 f. **June 20, 2025** – Deadline to Complete Discovery
- 18 g. **June 27, 2025** – Deadline to File Dispositive Motions
- 19 h. **July 9, 2025** – Deadline to File Pre-Trial Motions
- 20 3. Except as set forth herein, no other deadline set forth in the Joint Discovery
21 Plan is extended, modified, or amended by this Order and all other provisions of the Joint
22 Discovery Plan shall remain in full force and effect.
- 23 4. The parties shall file a joint pretrial statement by **July 11, 2025**.
