SERVICE

1. **THIS COURT ORDERS** that the time for service and filing of the notice of motion and the motion record is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.

APPROVAL OF THIRD REPORT

2. **THIS COURT ORDERS** that the Third Report and the actions, activities and conduct of the Proposal Trustee described therein be and are hereby approved; provided, however, that only the Proposal Trustee, in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

APPROVAL OF PROFESSIONAL FEES

3. **THIS COURT ORDERS** that the fees and disbursements of the Proposal Trustee and its legal counsel, A&B, in the total amounts of \$318,636.51 and \$108,374.95, respectively (both amounts inclusive of applicable sales taxes), as set out in the Third Report and the Fee Affidavits attached thereto as Appendices "K" and "L", respectively, be and are hereby approved.

RELEASES

4. THIS COURT ORDERS that each of A&B, as counsel to the Proposal Trustee, KSV in its capacity as Proposal Trustee and in its personal capacity, and Bennett Jones LLP, as counsel to the Company, and each of their respective affiliates and current and former officers, directors, partners, employees and agents, as applicable (collectively, the "Released Parties" and each a "Released Party") shall be and are hereby forever irrevocably released and discharged from any and all claims that any person may have or be entitled to assert against the Released Parties now or hereafter, whether direct or indirect, known or unknown, absolute or contingent, accrued or unaccrued, liquidated or unliquidated, matured or unmatured, foreseen or unforeseen or due or not yet due, in law or equity and whether based on statute or otherwise, based in whole or in part on any act or omission, transaction, dealing or other occurrence in any way relating to, arising out of, or in respect of, these BIA proceedings and/or with respect to their respective conduct in these BIA proceedings (collectively, the "Released Claims"), and any such Released Claims are hereby irrevocably and permanently released, discharged, stayed, extinguished and forever barred, and

the Released Parties shall have no liability in respect thereof; provided that, nothing in this paragraph shall waive, discharge, release, cancel or bar any claim or liability arising out of any gross negligence or wilful misconduct on the part of the applicable Released Party.

5. **THIS COURT ORDERS** that as of the date of this Order, the title of these BIA proceedings is hereby changed to:
