ENDORSEMENT OF JUSTICE W.D. BLACK:

- [1] The proposal trustee, joined by the debtor company, was before me today seeking:
 - (a) Approval of the proposal trustee's third report (dated May 28, 2024), and of the actions, conduct and activities of the proposal trustee (as described in that report);
 - (b) Approval of the fees of the proposal trustee and its counsel;

- (c) An amendment of the title of proceedings to reflect the Company's name change in accordance with the APA and Sales Approval Order (as defined and discussed in the materials); and,
- (d) A release for the proposal trustee, its counsel, and counsel for the company for their respective activities in this matter (save and except for gross negligence or wilful misconduct).
- [2] Having reviewed the materials, including the Third Report of the proposal trustee, I am satisfied that the relief sought is reasonable and appropriate in the circumstances.
- [3] With respect to the release, as my previous endorsement in this matter (dated April 3, 2024) reflects, as does correspondence since then (included in the record), two of the company's three directors, who attended on April 3, 2024, but not today, are critical of the Transaction approved on April 3, 2024, and have continued to express opposition in that regard. As set out in my previous endorsement, there is no basis evident in the record for that opposition. In my view the steps taken, including by the proposal trustee, have been reasonable and necessary.
- [4] Accordingly, I am granting the Order sought, including the release provisions. I find that the fees sought are reasonable and proportionate to the relevant activities.
