R.S.C. 1985, c. C-36 as amended (the "CCAA") in respect of the Respondents (the "Companies"), which was granted by an order dated March 13, 2024, amended and restated by order dated March 22, 2024 (the "Amended and Restated Initial Order"), which, among other things, appointed KSV Restructuring Inc. as CCAA Monitor (the "Monitor"), and, now or in the future, the Monitor applies for other relief under the CCAA as may be sought on notice of motion.

On motion of the Monitor, the following is ordered and declared:

### Service and Definitions

- 1. The service of the notice of motion in chambers and the supporting documents is hereby deemed adequate notice so that the motion is properly returnable today and further service thereof is hereby dispensed with.
- 2. Service of this Order is permitted at any time and place and by any means whatsoever.
- 3. All capitalized terms used in this Order and not defined herein shall have the meanings ascribed to them in the Sixth Report of the Monitor dated November 28, 2024 (the "Sixth Report").

### **Effective Time**

4. This Order and all of its provisions are effective as of 12:01 a.m. (Halifax time) on the date of this Order.

### **Extension of the Stay Period**

5. The Stay Period is hereby extended to March 28, 2025.

### **Approval of the Monitor's Report and Activities**

6. The Sixth Report, and the activities of the Monitor described therein, are hereby approved, provided, however, that only the Monitor, in its personal capacity and with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

connection with the motion scheduled for March 7, 2025.

8. This Order shall have full force and effect in all provinces and territories in Canada.

Canada, the United States of America or elsewhere, to give effect to this Order and to assist the

Companies, the Monitor and their respective agents in carrying out the terms of this Order. All

Courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to

make such orders and to provide such assistance to the Companies and the Monitor as may be

necessary or desirable to give effect to this Order, to grant representative status to the Monitor

or the authorized representative of the Companies in any foreign proceeding, to assist the

Companies and the Monitor, and to act in aid of and to be complementary to this Court, in

carrying out the terms of this Order.

10. Each of the Companies and the Monitor may apply to any court, tribunal, or regulatory or

administrative body, wherever located, for the recognition of this Order and for assistance in

carrying out the terms of this Order, and the Monitor may act as a representative in respect of

this proceeding for the purpose of having this proceeding recognized in a jurisdiction outside

Canada.
