CLAIM OF THE PETITIONER

Part 1: ORDER SOUGHT

- 1. An order (the "Receivership Order") substantially in the form attached as Schedule "A", which provides:
 - an order appointing KSV Restructuring Inc. ("KSV") as receiver of the property, assets, and undertakings of Minoru Square Development Limited Partnership (the "Minoru LP"), Minoru View Homes Ltd. (the "Minoru Nominee", together with the Minoru LP, the "Minoru Borrowers"), and 6511 Sussex Heights Development Ltd. (the "Highline Borrower" together with the Minoru Borrowers, the "Borrowers") for the purpose of the sale of the Borrowers' assets and distribution of proceeds thereof, pursuant to pursuant to section 243 of the Bankruptcy and Insolvency Act, RSC, 1985 C. B-3 (the "BLA") and section 39 of the Law and Equity Act, RSBC, 1996, C. 253 (the "LEA"); and

(b) such further and other relief as counsel may advise and this Court deems to be just and convenient in the circumstances.

Part 2: FACTUAL BASIS

Introduction

- 1. The Petitioner, KingSett Mortgage Corporation ("KingSett"), is a corporation incorporated under the *Canada Business Corporations Act* with an address for service of Bentall Four, 1055 Dunsmuir Street, Suite 3000 Vancouver, BC V7X 1K8.
- 2. The Borrowers are debtors to KingSett, each with an address for service of #700 401 West Georgia Street, Vancouver, BC V6B 5A1.

The Minoru Loan Agreement and Loan Documents

- Pursuant to a commitment letter dated October 18, 2021, as amended by a first amending agreement dated February 14, 2022, a second amending agreement dated March 20, 2023, and a third amending agreement dated February 23, 2024 (as may be further amended, restated, or supplemented from time to time, the "Minoru Commitment Letter"), KingSett provided to the Minoru Borrowers a first mortgage loan in the amount of \$72,650,000 (the "Minoru Loan").
- 4. Pursuant to the Minoru Commitment Letter, the Minoru agreed:
 - (a) to make monthly interest payments and missing a monthly interest payment constitutes an event of default (a "Minoru Event of Default") under the Minoru Commitment Letter;
 - (b) to pay KingSett accrued interest at a rate of the Royal Bank of Canada's "Prime Rate" plus 5.54% (with a floor rate of 12.24%), per annum, calculated on the daily outstanding balance, compounded and payable monthly;
 - to bear all costs and expenses incurred by KingSett in connection with the Minoru Loan;

- (d) that if a Minoru Event of Default occurs, KingSett has the right to demand repayment of the principal balance of the Minoru Loan outstanding, together with all accrued and unpaid interest, and all other costs incurred by KingSett, and may declare the principal balance of the Minoru Loan outstanding, together with all accrued and unpaid interest, and all other costs be forthwith due and payable; and
- (e) that if a Minoru Event of Default occurs, KingSett has the right to appoint a receiver over property of the Minoru Borrowers.
- 5. The Minoru Loan is secured by the following, among other things:
 - (a) a general security agreement dated October 29, 2021 (the "Minoru GSA") granted by the Minoru Nominee in favour of KingSett in respect of which a financing statement was filed in the British Columbia Personal Property Registry (the "PPR") against the Minoru Borrowers under base registration number 334886N on October 28, 2021;
 - (b) a mortgage and assignment of rents dated October 26, 2021 (the "First Minoru Mortgage") granted by the Minoru Nominee in favour of KingSett, which are registered in the New Westminster Land Title Office (the "LTO") on October 29, 2021 under registration numbers CA9469145 and CA9469146;
 - (c) a mortgage dated March 9, 2022 (the "Second Minoru Mortgage", together with the First Minoru Mortgage, the "Minoru Mortgages") granted by the Minoru Nominee in favour of KingSett, which is registered in the LTO on March 10, 2022 under registration number CA9774692;
 - (d) a Beneficial Direction, Acknowledgement, and Security Agreement dated October 29, 2021 granted by the Minoru Borrowers in favour of KingSett; and
 - (e) a Guarantee dated October 29, 2021 issued by, *inter alia*, the Highline Borrower in favour of KingSett.
 - ((a) through (e) collectively, the "Minoru Security")
- 6. The First Minoru Mortgage is a first ranking mortgage in the principal amount of \$61,000,000 and the Second Minoru Mortgage is a second ranking mortgage in the

principal amount of \$80,000,000. The Minoru Mortgages both charge the lands owned by the Minoru Nominee legally described as: LOT 1 SECTION 5 BLOCK 4 NORTH RANGE 6 WEST NEW WESTMINSTER DISTRICT PLAN EPP112775, PID 031-656-561 and municipally described as 5768 Minoru Blvd, Richmond (the "Minoru Property").

The Highline Loan Agreement and Loan Documents

- 7. Pursuant to a commitment letter dated March 5, 2024 (as may be further amended, restated, or supplemented from time to time, the "Highline Commitment Letter"), KingSett provided to the Highline Borrower a first mortgage inventory financing loan in the amount of \$176,500,000 payable in two tranches, by way of a term loan and cash in lieu of a letter of credit (the "Highline Loan").
- 8. Pursuant to the Highline Commitment Letter, the Highline Borrower agreed:
 - (a) to make monthly interest payments and missing a monthly interest payment constitutes an event of default (a "Highline Event of Default") under the Highline Commitment Letter;
 - (b) to pay KingSett accrued interest at a rate of the Royal Bank of Canada's "Prime Rate" plus 3.50% (with a floor rate of 10.70%), per annum, calculated on the daily outstanding balance, compounded and payable monthly;
 - (c) to bear all costs and expenses incurred by KingSett in connection with the Highline Loan:
 - (d) that if a Highline Event of Default occurs, KingSett has the right to demand repayment of the principal balance of the Highline Loan outstanding, together with all accrued and unpaid interest, and all other costs incurred by KingSett, and may declare the principal balance of the Highline Loan outstanding, together with all accrued and unpaid interest, and all other costs be forthwith due and payable; and
 - (e) that if a Highline Event of Default occurs, KingSett has the right to appoint a receiver over property of the Highline Borrower.

- 9. The Highline Loan is secured by the following, among other things:
 - (a) a general security agreement dated March 20, 2024 (the "Highline GSA") granted by the Highline Borrower in favour of KingSett in respect of which a financing statement was filed in the PPR against the Highline Borrower under base registration number 276856Q on March 27, 2024;
 - (b) a mortgage and assignment of rents dated March 14, 2024 (the "Highline Mortgage") granted by the Highline Borrower in favour of KingSett, which are registered in the LTO on March 26, 2024 under registration numbers CB1229018 and CB1229019;
 - (c) a collateral mortgage and assignment of rents dated March 14, 2024 (the "**Highline** Collateral Mortgage") granted by the Minoru Nominee in favour of KingSett, which are registered in the LTO on March 26, 2024 under registration numbers: CB1229022 and CB1229023; and
 - (d) a Guarantee dated March 21, 2024 issued by, *inter alia*, the Minoru Borrowers in favour of KingSett.
 - ((a) through (d) collectively, the "Highline Security")
- 10. The Highline Mortgage is a first ranking mortgage in the principal amount of \$283,750,000. The Highline Collateral Mortgage is in the principal amount of \$80,000,000 and charges the Minoru Property.

The Defaults and Demands

- 12. On September 1 and October 1, 2024:
 - (a) the Minoru Borrowers to make monthly interest payments to KingSett, as required pursuant to the Minoru Commitment Letter (the "Minoru Default"); and
 - (b) the Highline Borrower failed to make monthly interest payments to KingSett, as required pursuant to the Highline Commitment Letter (the "Highline Default", and together with the Minoru Default, the "Defaults").
- 13. Since the date of the Defaults, KingSett has attempted to work with the Borrowers to resolve payment difficulties, remedy the Defaults, and to obtain further information from

- the Borrowers that would allow KingSett to, among other things, assess whether its security is in jeopardy.
- 14. On October 11, 2024, KingSett through counsel, delivered a letter to the Minoru Borrowers advising of the Minoru Default (the "Minoru Demand"), attaching notices to enforce security as required by section 244 of the *Bankruptcy and Insolvency Act*, and:
 - (a) demanding payment of the outstanding amount owing under the Minoru Loan, inclusive of interest, which at that time amounted to \$74,159,665.83; and
 - (b) reserving all rights and remedies, including under the Minoru Security.
- 15. On October 21, 2024, KingSett through counsel delivered a letter to the Highline Borrower advising of the Highline Default (the "Highline Demand"), attaching notices to enforce security as required by section 244 of the *Bankruptcy and Insolvency Act*, and:
 - (c) demanding payment of the outstanding amount owing under the Highline Loan, inclusive of interest, which at that time amounted to \$141,151,126.89 with respect to the term loan and \$6,631,70.30 with respect to the cash in lieu of a letter of credit; and
 - (d) reserving all rights and remedies, including under the Highline Security.
- 16. To date, the Minoru Borrowers have not responded to the Minoru Demand, and the Highline Borrower has not responded to the Highline Demand. Both the Minoru Borrowers and the Highline Borrower have now failed to make the monthly interest payments due October 1, 2024 and November 1, 2024.
- 17. As a result of the Borrowers' failure to meet their financial obligations, KingSett has determined to exercise its contractual rights provided for in the Minoru Commitment Letter and the Highline Commitment Letter to take enforcement steps through the appointment of a receiver.

Borrowers' Indebtedness

- 18. The Minoru Borrowers remain indebted to KingSett as of November 1, 2024 of \$74,930,599.80 (the "Minoru Indebtedness"), particularized as follows:
 - (a) \$79,650,000 with respect to the principal amount due and owing with respect to the Minoru Loan;
 - (b) \$2,241,361.96 with respect to accrued and unpaid interest; and
 - (c) \$39,237.87 with respect to costs and charges incurred and unpaid in connection with the Minoru Loan.
- 19. The Minoru Indebtedness is incurring interest at a rate of \$24,868.84 a day and professional fees continue to be incurred.
- 20. The Minoru Indebtedness is fully due and owing and payable to KingSett and the Minoru Borrowers have failed or neglected, and continue to fail or neglect, to pay.
- 21. The Highline Borrower remains indebted to KingSett as of November 1, 2024 of \$146,020,840.41 (the "Highline Indebtedness"), particularized as follows:
 - (a) \$142,822,503.27 with respect to the principal amount due and owing with respect to the Highline Loan;
 - (b) \$3,173,269.94 with respect to accrued and unpaid interest; and
 - (c) \$25,067.21 with respect to costs and charges incurred and unpaid in connection with the Highline Loan.
- 22. The Highline Indebtedness is incurring interest at a rate of \$42,902.75 a day and professional fees continue to be incurred.
- 23. The Highline Indebtedness is fully due and owing and payable to KingSett and the Highline Borrower has failed or neglected, and continue to fail or neglect, to pay.

Loans are Related

- 24. The principal contacts of KingSett for both the Highline Borrower and Minoru Borrowers are the same people and for the sake of efficiencies, KingSett is requesting to appoint one receiver over both the Highline Borrower and Minoru Borrowers simultaneously.
- 25. In addition, the Highline Loan has been cross collateralized with a mortgage against the Minoru Property, therefore, KingSett is of the view that simultaneous enforcement of the Highline Security and Minoru Security will result in the most efficient outcome.

Part 3: LEGAL BASIS

Jurisdiction to Appoint the Receiver

26. The jurisdiction of this Court to grant the Receivership Order is found in subsection 39(1) of the *LEA* and section 243 of the *BIA*, among other statutes.

The Test for Appointing a Receiver

- 27. Subsection 39(1) of the *LEA* allows for the appointment of a receiver where it is "just or convenient" to do so.
- 28. Section 243 of the *BIA* provides that this Court may appoint a receiver to do any or all of the following if it considers it to be "just or convenient" to do so:
 - (a) take possession of all or substantially all of the inventory, accounts receivable or other property of an insolvent person or bankrupt that was acquired for or used in relation to a business carried on by the insolvent person or bankrupt;
 - (b) exercise any control that the court considers advisable over that property and over the insolvent person's or bankrupt's business; or
 - (c) take any other action that the court considers advisable.

- 29. In Maple Trade Finance Inc. v. CY Oriental Holdings Ltd., this Court identified several factors that may inform a holistic determination of whether it is "just and convenient" to appoint a receiver, including:
 - (a) whether irreparable harm might be caused if no order were made, although it is not essential for a creditor to establish irreparable harm if a receiver is not appointed, particularly where the appointment of a receiver is authorized by the security documentation;
 - (b) the risk to the security holder taking into consideration the size of the debtor's equity in the assets and the need for protection or safeguarding of the assets while litigation takes place;
 - (c) the nature of the property;
 - (d) the apprehended or actual waste of the debtor's assets;
 - (e) the preservation and protection of the property pending judicial resolution;
 - (f) the balance of convenience to the parties;
 - (g) the fact that the creditor has the right to appoint a receiver under the documentation provided for the loan;
 - (h) the enforcement of rights under a security instrument where the security-holder encounters or expects to encounter difficulty with the debtor and others;
 - (i) the principle that the appointment of a receiver is extraordinary relief which should be granted cautiously and sparingly;
 - (j) the consideration of whether a court appointment is necessary to enable the receiver to carry out its duties more efficiently;
 - (k) the effect of the order upon the parties;
 - (1) the conduct of the parties;
 - (m) the length of time that a receiver may be in place;
 - (n) the cost to the parties;
 - (o) the likelihood of maximizing return to the parties; and

(p) the goal of facilitating the duties of the receiver.

Maple Trade Finance Inc. v. CY Oriental Holdings Ltd., 2009 BCSC 1527 at para. 25,

30. In applying these factors, this Court has held that the contractual right of a secured creditor to apply for a receiver under a security agreement is a 'strong factor' in support of the imposition of a receiver and that 'considerable weight' can be placed on that contractual right.

It is Just and Convenient to Appoint a Receiver in the Circumstances

- The Minoru Loan and the Highline Loan have both been in default since September 1, 2024. The Minoru Borrowers have not remedied the Minoru Default and the Highline Borrower has not remedied the Highline Default.
- 32. KingSett is entitled to the appointment of a receiver over the property, assets, and undertakings of the Borrowers, pursuant to the Minoru Commitment Letter, the Highline Commitment Letter, the First Minoru Mortgage, the Second Minoru Mortgage, the Highline Mortgage, the Minoru GSA, and the Highline GSA. The Borrowers provided an express covenant agreeing to the appointment of a receiver in the event of a Default.
- 33. Courts should not interfere with a contract between parties in ordinary circumstances.
- In light of the express consent of by the Borrowers in the Minoru Commitment Letter and the Highline Commitment Letter, the First Minoru Mortgage, the Second Minoru Mortgage, the Highline Mortgage, the Minoru GSA, and the Highline GSA, there is no compelling commercial or other reason why the Receivership Order ought not to be made.

- 35. Appointment is also justified under the *BIA* and *LEA*. It is just and convenient in the present circumstances to appoint a receiver over the Borrowers' assets, undertakings, and property on the terms sought by KingSett for, among others, the following reasons:
 - (a) the Minoru Borrowers are indebted to KingSett as of November 1, 2024 in the amount of \$74,930,599.80, with interests and fees continuing to accrue, and have defaulted on their obligations to KingSett under the terms of the Minoru Commitment Letter;
 - (a) the Highline Borrower is indebted to KingSett as of November 1, 2024 in the amount of \$146,020,840.41, with interests and fees continuing to accrue, and have defaulted on their obligations to KingSett under the terms of the Highline Commitment Letter;
 - (b) since their initial non-payments and Defaults on September 1, 2024, the Borrowers have not remedied the Defaults;
 - (c) KingSett has lost confidence in the Borrowers' ability to satisfy their obligations;
 - (d) the Minoru Commitment Letter, the Highline Commitment Letter, the First Minoru Mortgage, the Second Minoru Mortgage, the Highline Mortgage, the Minoru GSA, and the Highline GSA grant KingSett the contractual right to appoint a receiver with the powers sought in the Receivership Order;
 - (e) it is necessary and expedient that the Minoru Property and the Highline Property be sold and that any marketing and sale process with respect to the Minoru Property and the Highline Property be transparent, orderly, timely, and undertaken under the supervision of this Court;
 - (f) the Minoru Property and the Highline Property are commercial properties that require specialize marketing and cannot be sold in the same manner as a residential property;
 - (g) the appointment of a receiver will protect the interests of all stakeholders; and

÷

- (i) the balance of convenience favours the appointment of a receiver in these circumstances.
- 36. The appointment of a receiver is further necessary to ensure that the Borrowers do not abscond with funds due and owing to KingSett. In relation to the Highline Loan, the Highline Borrower has already misappropriated funds in various contexts.
- 37. Firstly, the Highline Borrower received \$10,213,499 in cash in lieu of letter of credit funds returned from the city of Burnaby, which, without KingSett's knowledge was retained by the Highline Borrower. These funds should have been used to pay the Highline Indebtedness, as a representative for the Highline Borrower has admitted.
- 38. Secondly, the Highline Borrower received \$7,531,225 in GST funds following the sale of certain units on the Highline Property. Rather than remitting these funds to the Canada Revenue Agency, the Highline Borrower absconded with these funds and used the funds for internal obligations, which it would not disclose.
- 39. The instances particularized above relate to a total of \$17,744,724 wrongfully retained by the Highline Borrower, which should have been redirected to either KingSett or the Canada Revenue Agency. This abscondence of funds is concerning to KingSett that given the fact that the Highline Borrower and the related Minoru Borrowers are indebted to KingSett for a combined \$220,951,550.21 as of November 1, 2024.
- For the above reasons, KingSett submits that it is just and convenient that this Court appoint KSV as receiver of all the Borrowers' assets, undertakings, and property on the terms set out in the proposed Receivership Order.

ON THE APPLICATION of the Petitioner for an Order pursuant to Section 243(1) of the Bankruptcy and Insolvency Act, R.S.C. 1985, c. B-3, as amended (the "BIA") and Section 39 of the Law and Equity Act, R.S.B.C. 1996 c. 253, as amended (the "LEA") appointing KSV Restructuring Inc. ("KSV") as receiver (in such capacity, the "Receiver"), without security, of property described in Appendix A to this Order (the "Lands") and all right, title and interest of 6511 Sussex Heights Development Ltd., Minoru Square Development Limited Partnership, and

Minoru View Homes Ltd. (the "**Debtors**") in all presently owned or held personal property of whatsoever nature and kind pertaining to the Lands, including all proceeds, coming on for hearing this day at 800 Smithe Street, Vancouver, British Columbia.

AND ON READING Affidavit #1 of Daniel Pollack made November 5, 2024, and the consent of KSV to act as the Receiver; AND ON HEARING Emma Newbery, counsel for KingSett Mortgage Corporation and those other counsel listed on Schedule "A" hereto.

THIS COURT ORDERS AND DECLARES that:

APPOINTMENT

1. Pursuant to Section 243(1) of the *BIA* and Section 39 of the *LEA*, KSV is appointed Receiver, without security, of the Lands and all right, title and interest of the Debtors in all presently owned or held personal property of whatsoever nature and kind pertaining to the Lands (together with the Lands, the "**Property**"), including all proceeds.

RECEIVER'S POWERS

- 2. The Receiver is empowered and authorized, but not obligated, to act at once in respect of the Property and, without in any way limiting the generality of the foregoing, the Receiver is expressly empowered and authorized to do any of the following where the Receiver considers it necessary or desirable:
 - (a) to take possession of and exercise control over the Property and any and all receipts and disbursements arising out of or from the Property;
 - (b) to receive, preserve and protect the Property, or any part or parts thereof, including, but not limited to, changing locks and security codes, relocation of Property, engaging independent security personnel, taking physical inventories and placing insurance coverage;
 - (c) to manage, operate and carry on the business of the Debtors, including the powers to enter into any agreements, incur any obligations in the ordinary course of business, cease to carry on all or any part of the business, or cease to perform any contracts of the Debtors;
 - (d) to engage consultants, appraisers, agents, experts, auditors, accountants, managers, counsel and such other persons from time to time and on whatever basis, including on a temporary basis, to assist with the exercise of the Receiver's powers and duties, including, without limitation, those conferred by this Order;
 - (e) to purchase or lease such machinery, equipment, inventories, supplies, premises or other assets to continue the business of the Debtors or any part or parts thereof;
 - (f) to receive and collect all monies and accounts now owed or hereafter owing to the Debtors and to exercise all remedies of the Debtors in collecting these amounts, including, without limitation, enforcement of any security held by the Debtors;

- (g) to settle, extend or compromise any indebtedness owing to the Debtors;
- (h) to execute, assign, issue and endorse documents of whatever nature in respect of any of the Property, whether in the Receiver's name or in the name and on behalf of the Debtors, for any purpose pursuant to this Order;
- (i) to undertake environmental or workers' health and safety assessments of the Property and operations of the Debtors;
- (j) to initiate, manage and direct all legal proceedings now pending or hereafter pending (including appeals or applications for judicial review) in respect of the Debtors, the Property or the Receiver, including initiating, prosecuting, continuing, defending, settling or compromising the proceedings;
- (k) to market any or all of the Property, including advertising and soliciting offers in respect of the Property or any part or parts thereof and negotiating such terms and conditions of sale as the Receiver considers appropriate;
- (l) to sell, convey, transfer, lease or assign the Property or any part or parts thereof out of the ordinary course of business:
 - (i) without the approval of this Court in respect of a single transaction for consideration up to \$500,000 provided that the aggregate consideration for all such transactions does not exceed \$1,000,000, and
 - (ii) with the approval of this Court in respect of any transaction in which the individual or aggregate purchase price exceeds the limits set out in subparagraph (i) above,

and in each such case notice under Section 59(10) of the *Personal Property Security Act*, R.S.B.C. 1996, c. 359 shall not be required;

- (m) to apply for any vesting order or other orders necessary to convey the Property or any part or parts thereof to a purchaser or purchasers, free and clear of any liens or encumbrances;
- (n) to report to, meet with and discuss with such affected Persons (as defined below) as the Receiver considers appropriate on all matters relating to the Property and the receivership, and to share information, subject to confidentiality terms as the Receiver considers appropriate;
- (o) to register a copy of this Order and any other Orders in respect of the Property against title to any of the Property;
- (p) to apply for any permits, licences, approvals or permissions as may be required by any governmental authority and any renewals thereof for and on behalf of and, if considered necessary or appropriate by the Receiver, in the name of the Debtors;

- (q) to enter into agreements with any trustee in bankruptcy appointed in respect of the Debtors, including, without limitation, the ability to enter into occupation agreements for any property owned or leased by the Debtors;
- (r) to exercise any shareholder, partnership, joint venture or other rights which the Debtors may have;
- (s) to apply for remedies available under the *BIA*, including to declare or make an assignment into bankruptcy in respect of the Debtors; and
- (t) to take any steps reasonably incidental to the exercise of these powers or the performance of any statutory obligations,

and in each case where the Receiver takes any such actions or steps, it shall be exclusively authorized and empowered to do so, to the exclusion of all other Persons (as defined below), including the Debtors, and without interference from any other Person.

DUTY TO PROVIDE ACCESS AND CO-OPERATION TO THE RECEIVER

- Each of (i) the Debtors; (ii) all of the Debtors' current and former directors, officers, employees, agents, accountants, legal counsel and shareholders, and all other persons acting on its instructions or behalf; and (iii) all other individuals, firms, corporations, governmental bodies or agencies, or other entities having notice of this Order (collectively, "Persons" and each a "Person") shall forthwith advise the Receiver of the existence of any Property in such Person's possession or control, shall grant immediate and continued access to the Property to the Receiver, and shall deliver all such Property (excluding Property subject to liens the validity of which is dependent on maintaining possession) to the Receiver upon the Receiver's request.
- 4. All Persons, other than governmental authorities, shall forthwith advise the Receiver of the existence of any books, documents, securities, contracts, orders, corporate and accounting records, and any other papers, records and information of any kind related to the business or affairs of the Debtors, and any computer programs, computer tapes, computer disks, or other data storage media containing any such information (collectively, the "Records") in that Person's possession or control. Upon request, governmental authorities shall advise the Receiver of the existence of any Records in that Person's possession or control.
- 5. Upon request, all Persons shall provide to the Receiver or permit the Receiver to make, retain and take away copies of the Records and grant to the Receiver unfettered access to and use of accounting, computer, software and physical facilities, provided however that nothing in paragraphs 4, 5, or 6 of this Order shall require the delivery of Records, or the granting of access to Records, which may not be disclosed or provided to the Receiver due to solicitor client privilege or statutory provisions prohibiting such disclosure.
- 6. If any Records are stored or otherwise contained on a computer or other electronic system of information storage, whether by an independent service provider or otherwise, all Persons in possession or control of such Records shall forthwith give unfettered access to the Receiver for the purpose of allowing the Receiver to recover and fully copy all of the

information contained therein whether by way of printing the information or making copies of computer disks or such other manner of retrieving and copying the information as the Receiver in its discretion deems expedient, and shall not alter, erase or destroy any Records without the prior written consent of the Receiver. Further, for the purposes of this paragraph, all Persons shall provide the Receiver with all such assistance in gaining immediate access to the information in the Records as the Receiver may require including, without limitation, providing the Receiver with instructions on the use of any computer or other system and providing the Receiver with any and all access codes, account names and account numbers that may be required to gain access to the information.

NO PROCEEDINGS AGAINST THE RECEIVER

7. No proceeding or enforcement process in any court or tribunal (each, a "**Proceeding**"), shall be commenced or continued against the Receiver except with the written consent of the Receiver or with leave of this Court.

NO PROCEEDINGS AGAINST THE DEBTORS OR THE PROPERTY

8. No Proceeding against or in respect of the Debtors or the Property shall be commenced or continued except with the written consent of the Receiver or with leave of this Court and any and all Proceedings currently under way against or in respect of the Debtors or the Property are stayed and suspended pending further Order of this Court; provided, however, that nothing in this Order shall prevent any Person from commencing a Proceeding regarding a claim that might otherwise become barred by statute or an existing agreement if such Proceeding is not commenced before the expiration of the stay provided by this paragraph and provided that no further step shall be taken in respect of the Proceeding except for service of the initiating documentation on the Debtors and the Receiver.

NO EXERCISE OF RIGHTS OR REMEDIES

9. All rights and remedies (including, without limitation, set-off rights) against the Debtors, the Receiver, or affecting the Property, are stayed and suspended except with the written consent of the Receiver or leave of this Court, provided however that nothing in this Order shall (i) empower the Receiver or the Debtors to carry on any business which the Debtors are not lawfully entitled to carry on, (ii) affect the rights of any regulatory body as set forth in section 69.6(2) of the *BIA*, (iii) prevent the filing of any registration to preserve or perfect a security interest, or (iv) prevent the registration of a claim for lien. This stay and suspension shall not apply in respect of any "eligible financial contract" as defined in the *BIA*.

NO INTERFERENCE WITH THE RECEIVER

10. No Person shall discontinue, fail to honour, alter, interfere with, repudiate, terminate or cease to perform any right, renewal right, contract, agreement, licence or permit in favour of or held by the Debtors, without written consent of the Receiver or leave of this Court. Nothing in this Order shall prohibit any party to an eligible financial contract from closing out and terminating such contract in accordance with its terms.

CONTINUATION OF SERVICES

All Persons having oral or written agreements with the Debtors or statutory or regulatory mandates for the supply of goods and/or services, including without limitation, all computer software, communication and other data services, centralized banking services, payroll services, insurance, transportation services, utility or other services to the Debtors are restrained until further Order of this Court from discontinuing, altering, interfering with or terminating the supply of such goods or services as may be required by the Receiver, and the Receiver shall be entitled to the continued use of the Debtors' current telephone numbers, facsimile numbers, internet addresses and domain names, provided in each case that the normal prices or charges for all such goods or services received after the date of this Order are paid by the Receiver in accordance with normal payment practices of the Debtors or such other practices as may be agreed upon by the supplier or service provider and the Receiver, or as may be ordered by this Court.

RECEIVER TO HOLD FUNDS

12. All funds, monies, cheques, instruments, and other forms of payments received or collected by the Receiver from and after the making of this Order from any source whatsoever including, without limitation, the sale of all or any of the Property and the collection of any accounts receivable, in whole or in part, whether in existence on the date of this Order or hereafter coming into existence, shall be deposited into one or more new accounts to be opened by the Receiver (the "Post-Receivership Accounts") and the monies standing to the credit of such Post-Receivership Accounts from time to time, net of any disbursements provided for herein, shall be held by the Receiver to be paid in accordance with the terms of this Order or any further order of this Court.

EMPLOYEES

Subject to the employees' right to terminate their employment, all employees of the Debtors shall remain the employees of the Debtors until such time as the Receiver, on the Debtors' behalf, may terminate the employment of such employees. The Receiver shall not be liable for any employee-related liabilities of the Debtors, including any successor employer liabilities as referred to in Section 14.06(1.2) of the BIA, other than amounts the Receiver may specifically agree in writing to pay or in respect of obligations imposed specifically on receivers by applicable legislation, including sections 81.4(5) or 81.6(3) of the BIA or under the Wage Earner Protection Program Act, S.C. 2005, c.47. The Receiver shall be liable for any employee-related liabilities, including wages, severance pay, termination pay, vacation pay, and pension or benefit amounts relating to any employees that the Receiver may hire in accordance with the terms and conditions of such employment by the Receiver. The Receiver is empowered but not obligated to interact with, and provide direction to, individuals who are on the Property, but are not employed by the Debtors, in matters relating to safety, access and use of the Property.

PERSONAL INFORMATION

Pursuant to Section 7(3)(c) of the Personal Information Protection and Electronic Documents Act, S.C. 2000, c. 5 or Section 18(1)(o) of the Personal Information Protection Act, S.B.C. 2003, c. 63, the Receiver may disclose personal information of identifiable individuals to prospective purchasers or bidders for the Property and to their advisors, but only to the extent desirable or required to negotiate and attempt to complete one or more sales of the Property (each, a "Sale"). Each prospective purchaser or bidder to whom such personal information is disclosed shall maintain and protect the privacy of such information and limit the use of such information to its evaluation of the Sale, and if it does not complete a Sale, shall return all such information to the Receiver, or in the alternative destroy all such information. The purchaser of any Property shall be entitled to continue to use the personal information provided to it, and related to the Property purchased, in a manner which is in all material respects identical to the prior use of such information by the Debtors, and shall return all other personal information to the Receiver, or ensure that all other personal information is destroyed.

LIMITATION ON ENVIRONMENTAL LIABILITIES

- 15. Nothing in this Order shall require the Receiver to occupy or to take control, care, charge, possession or management (separately and/or collectively, "Possession") of any of the Property that might be environmentally contaminated, might be a pollutant or a contaminant, or might cause or contribute to a spill, discharge, release, or deposit of a substance contrary to any federal, provincial or other law relating to the protection, conservation, enhancement, remediation or rehabilitation of the environment or relating to the disposal of waste or other contamination (collectively "Environmental Legislation"), provided however that nothing herein shall exempt the Receiver from any duty to report or make disclosure imposed by applicable Environmental Legislation.
- The Receiver shall not, as a result of this Order or anything done in pursuance of the Receiver's duties and powers under this Order, be deemed to be in Possession of any of the Property within the meaning of any Environmental Legislation, unless the Receiver is actually in possession.
- 17. Notwithstanding anything in federal or provincial law, the Receiver is not personally liable in that position for any environmental condition that arises or environmental damage that occurred:
 - (a) before the Receiver's appointment; or,
 - (b) after the Receiver's appointment, unless it is established that the condition arose or the damage occurred as a result of the Receiver's gross negligence or wilful misconduct.
- 18. Notwithstanding anything in federal or provincial law, but subject to paragraph 17 of this Order, where an order is made which has the effect of requiring the Receiver to remedy any environmental condition or environmental damage affecting the Property, if the Receiver complies with the *BIA* section 14.06(4), the Receiver is not personally liable for

the failure to comply with the order and is not personally liable for any costs that are or would be incurred by any Person in carrying out the terms of the order.

LIMITATION ON THE RECEIVER'S LIABILITY

- 19. The Receiver shall incur no liability or obligation as a result of its appointment or the carrying out the provisions of this Order, save and except:
 - (a) any gross negligence or wilful misconduct on its part; or
 - (b) amounts in respect of obligations imposed specifically on receivers by applicable legislation.

Nothing in this Order shall derogate from the protections afforded the Receiver by Section 14.06 of the *BIA* or by any other applicable legislation.

RECEIVER'S ACCOUNTS

- 20. The Receiver and its legal counsel, if any, are granted a charge (the "Receiver's Charge") on the Property as security for the payment of their fees and disbursements, in each case at their standard rates, in respect of these proceedings, whether incurred before or after the making of this Order. The Receiver's Charge shall form a first charge on the Property in priority to all security interests, trusts, liens, charges and encumbrances, statutory or otherwise, in favour of any Person, but subject to Sections 14.06(7), 81.4(4), and 81.6(2) of the *BIA*.
- 21. The Receiver and its legal counsel shall pass their accounts from time to time, and for this purpose the accounts of the Receiver and its legal counsel are referred to a judge of the Supreme Court of British Columbia and may be heard on a summary basis.
- 22. Prior to the passing of its accounts, the Receiver shall be at liberty from time to time to apply reasonable amounts, out of the monies in its hands, against its fees and disbursements, including legal fees and disbursements, incurred at the standard rates and charges of the Receiver or its counsel, and such amounts shall constitute advances against its remuneration and disbursements when and as approved by this Court.

FUNDING OF THE RECEIVERSHIP

23. The Receiver is authorized and empowered to borrow by way of a revolving credit or otherwise, such monies from time to time as it may consider necessary or desirable, provided that the outstanding principal amount does not exceed \$250,000 (or such greater amount as this Court may by further Order authorize) at any time, at such rate or rates of interest as the Receiver deems advisable for such period or periods of time as it may arrange, for the purpose of funding the exercise of the powers and duties conferred upon the Receiver by this Order, including interim expenditures. The whole of the Property shall be and is charged by way of a fixed and specific charge (the "Receiver's Borrowings Charge") as security for the payment of the monies borrowed, together with interest and charges thereon, in priority to all security interests, trusts, liens, charges and encumbrances,

- statutory or otherwise, in favour of any Person, but subordinate in priority to the Receiver's Charge and the charges as set out in Sections 14.06(7), 81.4(4), and 81.6(2) of the BIA.
- 24. Neither the Receiver's Borrowings Charge nor any other security granted by the Receiver in connection with its borrowings under this Order shall be enforced without leave of this Court.
- 25. The Receiver is authorized to issue certificates substantially in the form annexed as Schedule "B" hereto (the "Receiver's Certificates") for any amount borrowed by it pursuant to this Order.
- 26. The monies from time to time borrowed by the Receiver pursuant to this Order or any further order of this Court and any and all Receiver's Certificates evidencing the same or any part thereof shall rank on a *pari passu* basis, unless otherwise agreed to by the holders of any prior issued Receiver's Certificates.

ALLOCATION

27. Any interested party may apply to this Court on notice to any other party likely to be affected for an order allocating the Receiver's Charge and Receiver's Borrowings Charge amongst the Property.

SERVICE AND NOTICE OF MATERIALS

- 28. The Receiver shall establish and maintain a website in respect of these proceedings (the "Website") at ______ and shall post there as soon as practicable:
 - (a) all materials prescribed by statute or regulation to be made publicly available, including pursuant to Rule 10-2 of the Supreme Court Civil Rules; and,
 - (b) all applications, reports, affidavits, orders and other materials filed in these proceedings by or on behalf of the Receiver, except such materials as are confidential and the subject of a sealing order or pending application for a sealing order.
- Any Person who is served with a copy of this Order and that wishes to be served with any future application or other materials in these proceedings must provide to counsel for each of the Receiver and the Applicant a demand for notice in the form attached as Schedule "C" (the "Demand for Notice"). The Receiver and the Applicant need only provide further notice in respect of these proceedings to Persons that have delivered a properly completed Demand for Notice. The failure of any Person to provide a properly completed Demand for Notice releases the Receiver and the Applicant from any requirement to provide further notice in respect of these proceedings until such Person delivers a properly completed Demand for Notice.
- 30. The Receiver shall maintain a service list identifying all parties that have delivered a properly completed Demand for Notice (the "Service List"). The Receiver shall post and maintain an up-to-date form of the Service List on the Website.

- Any interested party, including the Receiver, may serve any court materials in these proceedings by facsimile or by emailing a PDF or other electronic copy of such materials to the numbers or addresses, as applicable, set out on the Service List. Any interested party, including the Receiver, may serve any court materials in these proceedings by mail to any party on the Service List that has not provided a facsimile number or email address, and materials delivered by mail shall be deemed received five (5) days after mailing.
- 32. Notwithstanding paragraph 31 of this Order, service of the Petition and any affidavits filed in support shall be made on the Federal and British Columbia Crowns in accordance with the *Crown Liability and Proceedings Act*, R.S.C. 1985, c.C-50 and its regulations for the Federal Crown and the *Crown Proceedings Act*, R.S.B.C. 1996 c.89 in respect of the British Columbia Crown.
- 33. The Receiver and its counsel are authorised to serve or distribute this Order, any other orders and any other materials as may be reasonably required in these proceedings, including any notices or other correspondence, by forwarding copies by facsimile or by email to the Debtors' creditors or other interested parties and their advisors. For greater certainty, any such distribution or service shall be deemed to be in satisfaction of any legal or juridical obligation and notice requirements within the meaning of clause 3(c) of the *Electronic Commerce Protection Regulations*.

GENERAL

- Any interested party may apply to this Court to vary or amend this Order on not less than seven (7) clear business days' notice to the Service List and to any other party who may be affected by the variation or amendment, or upon such other notice, if any, as this Court may order.
- 35. The Receiver may from time to time apply to this Court for advice and directions in the discharge of its powers and duties hereunder.
- Nothing in this Order shall prevent the Receiver from acting as a trustee in bankruptcy of the Debtors.
- This Court requests the aid, recognition and assistance of any court, tribunal, regulatory or administrative body having jurisdiction, wherever located, to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All such courts, tribunals and regulatory and administrative bodies are respectfully requested to make such orders and to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.
- 38. The Receiver is authorized and empowered to apply to any court, tribunal or regulatory or administrative body, wherever located, for recognition of this Order and for assistance in carrying out the terms of this Order and the Receiver is authorized and empowered to act as a representative in respect of the within proceedings for the purpose of having these proceedings recognized in a jurisdiction outside Canada.

39. Endorsement of this Order by counsel appearing on this application other than the Petitioner is dispensed with.
